

COMPARING REPUBLICS IN ROME AND THE U.S.

Learning Objective(s): The student

1. Compare features of the ancient Roman Republic with the republic established by the U.S. Constitution.

TEKS: 8.15D; WH.3B; WH.20A

Materials Needed: Copies of the chart for each student; copies of the U.S. Constitution for each student.

Teaching Strategy:

1. Give each student a chart and a copy of the U.S. Constitution.
2. Using the citations in the U.S. Constitution, have the students fill out the chart explaining the comparisons to the Roman Republic.
3. After completing the chart, discuss the strengths and weaknesses of both.

Extension for GT/AP: Have the students locate other areas in the U.S. Constitution that could be used as a comparison to the Roman feature.
